Cancellation/Refund Policy

session without incurring any penalty. Failure to provide a 24-hour notice of cancellation before any session will result in the full cost of the session being due. Exceptions to the cancellation policy can be made at the discretion of the Founder/CEO in the event of an accident, illness, or other extenuating circumstances. If a child misses a session and a waiver of the penalty is being requested, proof of illness must be presented. Acceptable proof may include a doctor's note, school attendance record, or school note indicating the child's absence from school.

Any missed session fee that is due must be paid within 10 calendar of the missed session. Failure to do so will result in no further sessions being conducted until the outstanding balance is paid.
